#### Name: Billy Brotherston

Job: Independent Chair, North Ayrshire Alcohol & Drug Partnership



# You have been ADP Chair since January 2021, how have you found the role?

First of all, it's been a very steep learning curve – my previous role was as a Pastoral Depute Head Teacher which involved working with a range of agencies in support of children and families. I had some experience also of strategic working on various authority working groups and as a school senior manager but my current post is certainly a step up in that line.

Engaging with the Prevention & Service Support Team training

has certainly helped in bringing my knowledge up to date as has having conversations with a range of very experienced colleagues. Working with agencies that I had minimal contact with in my previous role such as Justice Services and Third Sector Organisations has also enhanced my understanding of the bigger picture.

#### What is your favourite part of the role?

Without a doubt, meeting so many new people and looking at the issues from that range of perspectives, whether they be Heads of Service, senior managers, staff on the ground or those with Lived Experience. Encouragingly everyone appears to be pulling in the same direction and there is a huge level of commitment to the task in hand.

Certainly a challenge is meeting virtually as direct face to face meetings will always give a better understanding and sense of how things are going. My intentions are to get out and about once restrictions have lifted and visit the various locations, staff and groups supported by the ADP.

#### What do you think is the biggest challenge for child protection within your area of work?

There are lots of challenges. For example, and as we all are acutely aware, children can suffer as a result of alcohol and substance use within the family, emotionally and physically. It has to be kept in mind that children by their very nature are extremely protective of their parents, even if being neglected or harmed as a result of their parent's actions/ lifestyles and I think that continued vigilance and awareness of the sensitivities involved is paramount amongst front line staff across agencies and amongst those making decisions at a strategic level.

#### What are your current main priorities within your work?

The priorities for the ADP are quite clear – to reduce the number of drugs related deaths in North Ayrshire and to provide clear routes to recovery for those who need that to regain control of their lives.

My current priority is to get myself up to speed with the issues which the ADP is designed to address. The multi agency composition of the ADP reflects the complexity of the problems facing individuals, families, and communities as a result of the negative aspects of alcohol and substance use. Despite having spent most of my career in education working with families, including those with issues relating to alcohol and/or drugs, I feel I still have much to learn.

I hope that, as I become more familiar with my role, I will make a contribution to the work of the ADP that has an impact on those who need it.

Billy ended by thanking Rosemary (Whyte), ADP Lead Officer and all his colleagues in the ADP Strategic Management Team, whom he credited as a significant support since coming into the role.

#### Practice Reflective Improvement Dialogue Pilot Project Update

The referral window for PRI Dialogue cases is now closed. Referrals have been received and we are now in the process of agreeing which cases will progress to a PRI Dialogue session. This means that practitioners across North Ayrshire may be invited to a PRI Dialogue session, **and this may be you.** 

PRI Dialogue sessions have been developed to provide a safe space for practitioners to reflect and learn on cases where there has been an element of child protection; this concerns both areas of strength and improvement. **Cases can by identified from any practitioner from agencies within North Ayrshire.** 



It is important to highlight that the purpose of these sessions is not to escalate cases, but to create an environment which supports all practitioners to reflect on practice and if anything could have been done differently.

PRI Dialogue sessions will be delivered by 2 trained facilitators. Both facilitators will be objective and have no prior involvement with the case. As the PRI Dialogue project is multi-agency, facilitators are from a range of different agencies and roles:
