

### What does your job involve?

"Being the Nurse Consultant for Child Protection, my duties are vast and varied, as you can imagine, but in summary my role is to provide strategic and professional leadership to all Health staff and services across NHS Ayrshire and Arran. This involves appropriate the NHS Board in delivering high quality, acres and effective

involves supporting the NHS Board in delivering high quality, safe and effective child protection services that promote wellbeing, early intervention and support for children and their families.



## What do you think is the biggest challenge for child protection within your area of work?

"The biggest challenge without a doubt is the emotive side of working in child protection. It can be very stressful for staff dealing with complex and distressing situations and it is important to recognise this and support staff to ensure their well-being at all times, whilst being mindful of your own well-being.

With the addition of the current COVID-19 situation, we are all working together to ensure CP Services are not affected which brings its own challenges. There are numerous competing demands on a daily basis, which entails prioritising and re-prioritising tasks to ensure complex situations are always managed, whilst ensuring the wellbeing of staff and meeting strict deadlines.

I'd like to add that all staff are looking after each other across the partnerships in these times and we are very lucky to have these relationships in place."

#### What are your current main priorities within your work?

"We recognise the importance of effective partnership working, so it is a priority to strengthen how we work together across health services and with partner agencies to improve CP practice and achieve a consistent approach to keeping children and young people safe".

#### What is your favourite part of your role?

"Although the job can be stressful, it is one I am very passionate about and have a fantastic team. It is so rewarding to actually see the positive outcomes for children and young people and knowing that we are making a difference. I have met such amazing people since coming Ayrshire 4 years ago and established not just good relationships but also friendships. I feel the job is a privilege and I'm very lucky to be in this role".
